1. Eligibility Criteria / Terms & Conditions:

- (a) The firm from should be authorized dealer/ supplier for undertaking supply & installation of Wifi Card Attendance System and should possess:
 - (i) Up-to-date Trade License, ii) GST Registration & iii) Pan Card.
- (b) The firm should have minimum three (3) years of experience in supply, installation and after sales service at site in Govt. Organizations/Semi-Govt., organizations/Corporations/ Public Sector Undertakings/ Autonomous Bodies etc.
- (c) The firm should have annual financial turnover of Rs.20.00 lakh in last three years i.e. FY 2018-19,2019-2020 & 2020-2021 from supply/ service of Card Attendance System and related services etc.
- (d) The firm should not be blacklisted/debarred/suspended/banned from business dealing by any Ministry/ Department of State/Central Government/PSU/ Private sector / Autonomous bodies as on date of filling the responses of this tender.
- (e) Bid Security @ 2% on the total bid value to with a validity of 180 days should be submitted in the form of FDR/TDR drawn in favour of the "Director, SIPRD, Assam" payable at "Guwahati".
- (f) At any time prior to the date of submission of tender, the Tender Inviting Authority may, for any reason, whether on his own initiative or in response to a clarification requested by a prospective Bidder, may modify the tender document by an amendment and that will be binding on them. A pre-bid meeting may be held on **30-10-2021 at 15:00** hours to address the query of prospective bidder, if any.
- (g) The last date of receipt of tenders is 13:00 hours on 11-11-2021 and the technical bid will be opened at 13:15 hours on the same date in the presence of bidders / authorized representatives who choose to attend during opening of the Technical Bid. The schedule for opening financial bid will be on the same day failing which fresh date will be notified separately to the successful technical bidders. The financial bid for those bidders will be opened whose technical bid are found to be responsive.
- (h) At any point of the process, the information furnished / materials supplied by the bidder is found to be incorrect, the bidder shall be liable to be debarred from tendering/taking up of work in SIPRD, Assam. The Institute reserves the right to verify the particulars furnished by the applicant to the Institute, independently.
- (i) The Institute reserves the right to increase or decrease the scope of work. The number and quantity mentioned in the Tender document is the probable number/quantity required to be procured. The same may be increased/decreased and the delivery of the items may be according to the requirement.
- (j) Terms and conditions, which are not specified, herein above will be governed by the decision of the Institution.
- (k) The detailed tender paper will also be a part of the contract agreement.
- (1) The Director, SIPRD, Assam reserves the right to reject any or all tenders without assigning any reason thereof and may increase or decrease the scope of work as indicated.

2. Scope of work:

The SIPRD, Assam intends to introduce Wifi Card Attendance System for the Officers and staff working under the SIPRD, Assam. The Card is also intended to be used as "Identity Card" for which customized printing is required to be carried out on the RFID card. A customized report generation provision is should be included in the proposal. The scope of work includes:

- 1. Supply and installation RFID Card Attendance system in 19 different locations.
- 2. Supply of RFID Card & customized printing with strap.
- 3. Development of Software for report generation.

The timeline for completion for supply, installation & commissioning will be within 4(four) weeks from the date of workorder. The scope of work is indicative. In case of any query, interested bidders are requested to visit Office of the SIPRD, Assam.



3. Technical Bid: Form -A

The Bidder should furnish the following documents in a separate cover hereinafter termed "Form-A".

Annual Turnover	Annual turnover statement for three financial years i.e 2018-19, 2019-2020 & 2020-21 in the format given in Form-II duly certified by the Auditor/Chartered Accountant.

The tender document is required to be signed by the Bidder in all pages with office seal. The above documents should be sealed in a separate cover superscribed as "Technical Bid – Supply of RFID Attendance System" addressed to the Director, State Institute of Panchayat & Rural Development, Assam, G.S. Road, Khanapara, Guwahati-781022, Assam.

4. Financial Bid: Form -B

The Bidder should furnish the following documents in a separate cover hereinafter called "Financial Bid".

- (i) The bidder shall have to submit the Price Bid stating, specification of the item, rate, taxes and carriage to destination as per schedule given at Financial Bid- Form-V of the bid document. Price Bid should be duly signed by the Bidder affixing the office seal.
- (ii) The Bid should be typewritten and every correction in the bid should be attested with full signature by the Bidder, failing which the bid will be ineligible. Corrections done with correction fluid should also be duly attested.

The above documents should be sealed in a separate cover super scribed as "Financial Bid- Supply of RFID Attendance System" addressed to the Director, State Institute of Panchayat & Rural Development, Assam, G.S. Road, Khanapara, Guwahati-781022, Assam.

The two separately sealed covers Technical bid and Financial Bid shall be placed together inside another cover which shall be sealed and superscripted as "Tender for Supply of RFID Attendance System" addressed to the Director, State Institute of Panchayat & Rural Development, Assam, G.S. Road, Khanapara, Guwahati-781022, Assam.

5. Validity of Bid & Validity of Offer.

Bids shall remain valid for acceptance for a period of 180 days on opening of Technical Bid. Bids with shorter validity shall be rejected.

6. Other conditions

No Revision/Correction of Rates: No Bidder shall be allowed at any time on any ground whatsoever to claim revision or modification in the rates quoted by him. Representation to make correction in the tender documents on the



ground of clerical error, typographical error, etc., committed by the bidders in the Bids shall not be entertained after submission of the bids.

7. Tender Evaluation & Acceptance of Tender

Tender Evaluation: Tenders will be evaluated with reference to technical and financial parameters to determine the qualification bidders. Price Bid of technically qualified bidders will be evaluated with reference to the quoted rates. Supply work should ordinarily be awarded to the lowest evaluated bidder whose bid has been found to be responsive and found eligible and qualified to perform the supply work satisfactorily as per requirement within the terms and conditions incorporated in this bid document. The acceptance of the tenders will be communicated to the successful bidders in writing.

8. Performance Security

The successful Bidder shall have to submit performance security deposit amounting to 8% of the work order value by way of FDR/TDR of a scheduled bank and shall execute an agreement incorporating all terms & conditions of service on a non-judicial stamp paper of value of Rs. 100/- (stamp duty to be paid by the Bidder) within 10 days from the date of issue of workorder.

9. Payment provisions:

Payments towards the supply work will be made strictly as per rules of the Tender Inviting Authority.

10. Annulment of award, forfeiture of security deposit & fresh award.

Failure of the successful bidder to comply with the requirements of signing of agreement and / or submission of performance security within the time schedule as stipulated above shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security/EMD. Under such a situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance. In case it is decided to go for the next lowest bidder, negotiation may be considered to bring down their price nearer to the originally evaluated lowest bidder.

11. Laws Governing the Contract & Jurisdiction.

The contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender such dispute would be subject to the jurisdiction of the Court at Guwahati in the State of Assam only.
