#### 3. Validity of Bid & Validity of Offer.

Bids shall remain valid for acceptance for a period of 180 days on opening of Technical Bid. Bids with shorter validity shall be rejected.

#### 4. Other conditions

No Revision/Correction of Rates: No Bidder shall be allowed at any time on any ground whatsoever to claim revision or modification in the rates quoted by him. Representation to make correction in the tender documents on the ground of clerical error, typographical error, etc., committed by the bidders in the Bids shall not be entertained after submission of the bids.

#### 5. Tender Evaluation & Acceptance of Tender

Tender Evaluation: Tenders will be evaluated with reference to technical and financial parameters to determine the qualification bidders. Price Bid of technically qualified bidders will be evaluated with reference to the quoted rates. Supply work should ordinarily be awarded to the lowest evaluated bidder whose bid has been found to be responsive and found eligible and qualified to perform the supply work satisfactorily as per requirement within the terms and conditions incorporated in this bid document. The acceptance of the tenders will be communicated to the successful bidders in writing.

#### 6. Performance Security

The successful Bidder shall have to submit performance security deposit amounting of Rs.10000.00 (Ruppes Ten Thousand) only in the form of FDR/TDR/Bank Guarantee drawn in favour of the "Director, SIPRD, Assam" payable at "Guwahati". and shall execute an agreement incorporating all terms & conditions of service on a non-judicial stamp paper of value of Rs. 100/- (stamp duty to be paid by the Bidder) within 10 days from the date of issue of work order.

#### 7. Payment provisions:

Payments towards the supply work will be made strictly as per rules of the Tender Inviting Authority.

#### 8. Annulment of award, forfeiture of security deposit & fresh award.

Failure of the successful bidder to comply with the requirements of signing of agreement and / or submission of performance security within the time schedule as stipulated above shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security/EMD. Under such a situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance. In case it is decided to go for the next lowest bidder, negotiation may be considered to bring down their price nearer to the originally evaluated lowest bidder.

#### 9. Laws Governing the Contract & Jurisdiction.

The contract shall be governed by the laws in force in India. In the event of any dispute arising out of the tender such dispute would be subject to the jurisdiction of the Court at Guwahati in the State of Assam only.
